

## Cookie Policy

**Version December 2024**

**NASCENT**, operating as a part of UHasselt with its registered office located at Martelarenlaan 42, 3500 Hasselt, uses cookies to improve the browsing experience on <https://www.nascent.live> (hereinafter referred to as the “**Website**”). These cookies enable certain functions on our Website or measure how visitors use our Website.

With this cookie policy (“**Cookie Policy**”) we wish to inform you, as a visitor to our Website, about the cookies and other tracking methods we use (and the way we do this).

### **What are cookies?**

A cookie is a small text file stored in your computer's browser or on your mobile device by a website's server when you visit the site. It contains a unique code that enables your browser to be recognized either during your current session (a "session cookie") or during subsequent visits (a "persistent cookie"). Cookies may be placed by the website's server or by third-party partners the site works with. The website's server can only read the cookies it has placed and cannot access any other information on your device. These cookies are stored in a designated folder within your browser.

Cookies enhance the user experience by making interactions with the Website smoother and faster, and by simplifying navigation across its sections. Additionally, cookies can tailor the Website's content to better align with the visitor's preferences and needs, ensuring a more personalized experience.

### **This Website uses different types of cookies and tracking methods**

#### **I. Strictly necessary cookies**

These cookies are necessary for purely technical reasons for the use of the Website. In view of the technical necessity, there is only an information obligation and they are placed as soon as one enters the Website.

## **III. Analytical cookies**

Analytical cookies allow us to measure how visitors use our Website. Based on this information, user statistics and reports can be generated. This enables us to improve the performance of the Website and thus provide a better user experience.

The analytical cookies collect, among other things, the following data

- The number of visitors on the Website;
- How long a visitor visits the Website;
- Information about the browser and devices used to visit our Website;
- How the visitor ended up on the Website;
- The speed of our Website;
- The fonts used on the Website.
